## Special features of the location

The fountain in the Brunnenhof is expected to be in operation during the event and must be always visible and accessible.

The exhibition areas are located in a historical ensemble, which brings with it different conditions in each courtyard, which may have an impact on the stand design.

In some areas, it is possible to see onto the roofs of the exhibition buildings. This should be taken into account when all the stand structures.

### Power supply

Apothekenhof: 150 W available per m<sup>2</sup> of stand space Brunnenhof: 150 W available per m<sup>2</sup> of stand space Kaiserhof: 200 W available per m<sup>2</sup> of stand space

Depending on overall requirements, deviations may occur and must be checked individually.

The cable routing is planned individually and is always via the corridor. The final planning is carried out after an overall space inspection.

It may be necessary to route cables through other areas to supply individual stand areas.

### Water supply

Water and wastewater connections are generally available, but must be checked and coordinated according to the demand of all exhibitors by the Site Manager.

#### Floor load

The permissible point load on a base area of 50 cm by 50 cm (distance approx. 1.50 m) is 5 t (50 kN, ground pressure 200 kN/m²).

Special regulations apply in the area of the historic vaults in the Apothekenhof, which may have to be subjected to static tests for a fee.

#### Floor protection

To protect the historic existing floor, both the general circulation areas and the exhibition areas will be provided with floor protection. This work will be carried out exclusively by Messe München GmbH. The costs will be charged to exhibitors according to the size of their stand.

The contours of the stand areas are adapted to the floor protection grid. Detailed planning is coordinated via the Site Manager.

#### Construction height

Maximum construction and advertising height: 6.50 m Deviating construction heights are checked individually depending on the location.

## **Logistics**

Delivery traffic for Kaiserhof and Brunnenhof is only possible via the Apothekenhof.

There are no areas available for temporary storage or other use in the residence outside the rented stand areas.

Loading and unloading takes place exclusively within the rented areas.

The organizer shall appoint a supervisor to manage the overall logistics in the residence courtyards. The costs will be charged to the exhibitors on a pro rata basis.
